Focus of the Conference

The Union institution is determined to make strategy of the European Commission "Digital Decade" of Europe. It is time for Europe to consolidate its digital sovereignty and set the standards according to European moral and cultural principles, rather than following those of, with a clear focus on data, technology and infrastructure.

Cybersecurity and usage of AI of the network and information systems in the European Union is essential. Protecting communications and data and keeping society and the digital economy running are basic premises for European digital development. Nor less important are digital transformation of healthcare and impact of data governance in the context of legal and ethical challenges posed in the European Digital Single Market.
